KBR -- a former subsidiary of the Halliburton energy firm was at the time the largest contractor servicing the US military in Iraq. More...

### **Cheesecake Factory**


In San Antonio, Texas a man worked as a bartender at the Cheesecake Factory. He befriended a waitress who worked there and they allegedly conspired with her to sell her 5 year old and 10 month-old daughter for commercial sex. He arranged for the sale with an undercover federal agent. The case has links to a Russian child porn site. When they two were arrested, the local new stations and newspaper gave this story extensive coverage.

The Cheesecake Factory was mentioned prominently and will be at risk for further exposure as the investigation continues and the trial begins. Since this is known as a family restaurant it was shocking news to most in the community. One individual said "My daughter and I always eat there. I am very concerned to think that such an ugly kind of crime against children could occur in such a family oriented place." More...





# H.R.7311 William Wilberforce - Trafficking Victims Protection Reauthorization Act of 2008

(Enrolled as Agreed to or Passed by Both House and Senate)
Section 105 GENERAL- An applicant desiring a grant, contract, or cooperative agreement under this Act shall certify that, to the extent practicable, persons or entities providing legal services, social services, health services, or other assistance have completed, or will complete, training in connection with trafficking in persons (source THOMAS LAW).

# President Bush's January 16, 2009 Proclamation

To Suspend Entry as Immigrants and Nonimmigrants of Foreign Government Officials Responsible for Failing to Combat Trafficking in Persons

A Proclamation by the President of the United States of America In order to foster greater resolve to address trafficking in persons (TIP), specifically in punishing acts of trafficking and providing protections to the victims of these crimes. (read more page 5).

- If you are part of an organization you need to have policies and procedures that protect your business or organization from human trafficking activities. This crime is a high priority for the Department of Justice, the Department of State, Department of Labor and the Texas Attorney General, and other key enforcement organizations.
- Human Trafficking organizations are infiltrating legitimate businesses and putting their staff, customers, and executives at numerous civil and criminal risks.
- According to the Trafficking Victims Protection Act any government contractor whose employees, subcontractors or their employees who engage in human trafficking will lose all government funding.
- Due to the new **PROTECT Act** any US citizen who has sex with a minor while abroad may be prosecuted federally upon their return to the United States.
- The Trafficking Victims Reauthorization Act requires all organizations that receive funding to combat human trafficking must train their staff.
- The new anti-trafficking laws allow law enforcement to use RICO (racketeering) statues to seize all assets related to the crime.
- All victims of human trafficking may sue for lost wages, pain and suffering, and restitution from everyone involved in the trafficking.
- All investigators and law enforcement officials need training on the <u>new</u> 2008-09 criminal laws and mandates for victim protections of the anti trafficking acts.
- Governments outside the US need training due to possible sanctions placed against countries that do not comply with the US State Department's annual Trafficking in Persons Report (see page 5).
- Civil trial attorneys trained in human trafficking will be on the cutting edge of the next wage civil trial law. Awards in human trafficking cases have been extremely high.

#### **Dottie Laster**

Dottie Laster began work on human trafficking while earning her Master's degree in International Relations at St. Mary's University in San Antonio, Texas. She took elective courses in Mediation and Arbitration in Paris, France and Budapest, Hungary with Hamline School of Law. Dottie next worked for YMCA International Services where she was appointed an original member of the U.S. Attorney's Human Trafficking Rescue Alliance, which consists of F.B.I., Immigration and Customs Enforcement, U.S. State Department's Diplomatic Security Service, Texas Rangers, Houston Police Department, Department of Labor, and YMCA. There she wrote grants that funded the task force from the Bureau of Justice Assistance, worked directly with victims to provide service and restoration of their lives. She trained over 5,000 Houston Police Officers on human trafficking. While in Houston, she coordinated victim services and law enforcement in human trafficking cases identified in commercial sex and forced labor cases. Dottie also assisted children affected by Hurricane Katrina by coordinating efforts with Ricky Martin and his foundation to deliver toys to the displaced children and later to assist the

Dottie's next role was a Coordinating Producer in the documentary film Cargo Innocence Lost. There she assisted the filmmakers in gaining interviews with real survivors of human trafficking, coordinated the full cooperation of the Department of Justice and local law enforcement officials. Cargo is now used by the Department of Justice, FBI, and Health and Human Services to train on the issue of human trafficking. After production on Cargo was completed she then took on the newly funded Orange County Human Trafficking Task Force. There she coordinated law enforcement training and victim assistance and was the Orange County Chair for the Rescue and Restore Southern California Coalition. She participated in the rescue of victims and worked with celebrities such as Anne Archer and Daryl

# To Suspend Entry as Immigrants and Nonimmigrants of Foreign Government Officials Responsible for Failing to Combat Trafficking in Persons

A Proclamation by the President of the United States of America In order to foster greater resolve to address trafficking in persons (TIP), specifically in punishing acts of trafficking and providing protections to the victims of these crimes, consistent with the Trafficking Victims Protection Act of 2000, as amended (the "Act") (22 U.S.C. 7101 et seq.), it is in the interests of the United States to restrict the international travel and to suspend entry into the United States, as immigrants or nonimmigrants, of certain senior government officials responsible for domestic law enforcement, justice, or labor affairs who have impeded their governments' antitrafficking efforts, have failed to implement their governments' antitrafficking laws and policies, or who otherwise bear responsibility for their governments' failures to take steps recognized internationally as appropriate to combat trafficking in persons, and whose governments have been ranked more than once as Tier 3 countries, which represent the worst anti-TIP performers, in the Department of State's annual Trafficking in Persons Report, and for which I have made a determination pursuant to section 110(d)(1)-(2) or (4) of the Act. The Act reflects international antitrafficking standards that guide efforts to eradicate this modern-day form of slavery around the world.

NOW, THEREFORE, I, GEORGE W. BUSH, President of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, including section 212(f) of the Immigration and Nationality Act of 1952, 8 U.S.C. 1182(f), and section 301 of title 3, United States Code, hereby find that the unrestricted immigrant and nonimmigrant entry into the United States of persons described in section 1 of this proclamation would, except as provided for in sections 2 and 3 of this proclamation, be detrimental to the interests of the United States.

I therefore hereby proclaim that:

Section 1. The entry into the United States, as immigrants or nonimmigrants, of the following aliens is hereby suspended:

- (a) Senior government officials -- defined as the heads of ministries or agencies and officials occupying positions within the two bureaucratic levels below those top positions -- responsible for domestic law enforcement, justice, or labor affairs who have impeded their governments' antitrafficking efforts, have failed to implement their governments' antitrafficking laws and policies, or who otherwise bear responsibility for their governments' failures to take steps recognized internationally as appropriate to combat trafficking in persons, and who are members of governments for which I have made a determination pursuant to section 110(d)(1)-(2) or (4) of the Act, in the current year and at least once in the preceding 3 years;
- (b) The spouses of persons described in subsection (a) of this section.
- Sec. 2. Section 1 of this proclamation shall not apply with respect to any person otherwise covered by section 1 where entry of such person would not be contrary to the interest of the United States.
- Sec. 3. Persons covered by sections 1 or 2 of this proclamation shall be identified by the Secretary of State or the Secretary's designee, in his or her sole discretion, pursuant to such procedures as the Secretary may establish under section 5 of this proclamation.
- Sec. 4. Nothing in this proclamation shall be construed to derogate from United States Government obligations under applicable international agreements.
- Sec. 5. The Secretary of State shall implement this proclamation pursuant to such procedures as the Secretary, in consultation with the Secretary of Homeland Security, may establish.
- Sec. 6. This proclamation is effective immediately. It shall remain in effect until such time as the Secretary of State determines that it is no longer necessary and should be terminated, either in whole or in part. Any such determination by the Secretary of State shall be published in the Federal Register.
- Sec. 7. This proclamation is not intended to, and does not, create any right, benefit, or privilege, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, instrumentalities, or entities, its officers or employees, or any other person.

IN WITNESS WHEREOF, I have hereunto set my hand this sixteenth day of January, in the year of our Lord two thousand nine, and of the Independence of the United States of America the two hundred and thirty-third.
